

SUBJECT: Army Library Institute (ALI) 2001

1. As proponent for the Army Library Program, I ask you to support this year's Army Library Institute (ALI), which will convene 5 through 8 June 2001, at the St. Anthony Hotel, in San Antonio, Texas. You can do this best by ensuring that librarians in your command or agency are afforded the opportunity to participate in the ALI.

2. The ALI is the Army's primary professional training and development opportunity for all of its librarians. It is partially funded by the Army Civilian Training, Education, and Development System (ACTEDS) in support of the Librarian Career Program. Attendee registration and TDY costs are funded locally. The ALI trains Army librarians to meet the challenges created by rapidly occurring changes within DoD as well as in the information technology arena. For example, the sessions focusing on knowledge management, digital reference services, and the Army Continuing Education System (ACES) initiatives will expose them to new ideas and ways to support the Army's goals of developing leaders, recruiting and retaining the best, promoting life-long learning and providing for the well-being of soldiers, civilians, and family members. It will also prepare them to deliver information and library services to the soldier as expected in the Internet age - any time, any place.
